1. SWEEPSTAKES PERIOD:

Sweepstakes begins at 12:00 a.m. CT on 6/1/17 and ends at 11:59 p.m. CT on 7/31/17 ("Sweepstakes Period").

2. **HOW TO ENTER:** During the Sweepstakes Period, you can enter via the following methods: **(a) TEXT MESSAGE:** Use your mobile phone to text **DEWSWEEPS** to **72727** and you will be automatically entered into the Sweepstakes. Participants must have a mobile phone with text messaging capabilities to enter by text message and may incur standard text message and data charges from their wireless service provider for each message sent and received. Approximately a total of four (4) text messages will be required to participate. Check with your wireless service provider for details on any applicable charges. Participants are solely responsible for any such wireless charges. Not all wireless carriers participate. 5. **DRAWING:** Potential winner will be selected in a random drawing from among all eligible entries received throughout the Sweepstakes Period. Odds of winning depend upon the total number of eligible entries received. Drawing will occur on or about 8/3/17 and will be conducted by an independent judging organization, whose decisions shall be final and binding. Ten (10) prize will be awarded.
6. **WINNER NOTIFICATION:** Potential winner will **be notified** by text, phone, mail and/or email at the text, phone, mail and/or email address provided upon entry, within two (2) days of the drawing. If a potential prize winner is notified by text or phone, he/she will be required to respond within seventy-two (72) hours or prize will be forfeited and may be awarded to an alternate winner. Sponsor is not responsible for suspended or discontinued wireless service which may result in a potential winner not receiving initial prize notification.
